The Society offers its members the opportunity to further develop their professional skills, network and exchange information and ideas with their associates in a variety of forums.

Eligibility Requirements

Membership is open to those who have practiced public relations and/or communications for at least five years and are of known professional competence.

Endorsements

Applicants for membership in the Society must be sponsored by two references one of which being a board member.

Type of Membership

Professional Members, open to any person who meets the eligibility requirements stated above. Entitles member to all rights and privileges of the Society, receiving a free copy of the Society's Membership and Media Directory, and participating in other Society program for members. **Annual dues: Rp. 1.000.000,-**

Associate Members, open to any person who meets the eligibility requirements not specifically in public relations and/or communications. Entitles member to all rights and privileges of the Society, receiving a free copy of the Society's Membership and Media Directory, and participating in other Society program for members. **Annual dues: Rp. 1.000.000,-**

Student Members, open to any full-time undergraduate student majoring in communications, journalism, and public relations who has completed three full years of college education. Entitles member to rights and privileges of the Society except to vote and hold office and receive a copy of the Society's Membership and Media Directory. **Annual dues: Rp. 500.000,-**

Senior / Life Members, open to any person who meets the eligibility requirements and has been a member in good standing. Entitles to all benefits of membership, the rights to vote and receive a copy of the Society's Membership and Media Directory, and special discount at Society's programs. **Annual dues: Rp. 750.000,-**

Corporate Members, open to any person who's company gives privileges and concern of strategic corporate communications to minimum five members of the company. Entitles to all rights and privileges of the Society, receiving a free copy of the Society's Membership and Media Directory, and participating in other Society program for members. **Annual dues: Rp. 4.500.000,-**
